Banquet:

Field Trips

Two field trips are scheduled for Sunday, March 28th. Both field trips are free of charge, but optional box lunches are available from Sodexo located in the Lodge at a price of \$7.20. Transportation is not provided and car-pooling is encouraged.

Field Trip 1: Fort Carson

Participants will travel by private auto to the Ft. Carson main gate, approximately 10 miles south of the UCCS campus. From there, they will be transported by military vehicles to downrange archaeological sites. The exact sites to be visited will depend on training activities being conducted at the time, but will probably include Apishipa architecture and historical sites. This trip is limited to no more than 30 participants, to be determined by order of sign-up.

Field Trip 2: Calhan Paint Mines

Participants will travel by private vehicle to the entrance to this undeveloped El Paso County Park, approximately 20 miles east of Colorado Springs. The Paint Mines are concentrations of differently colored clays that were a source of ceramic raw materials for prehistoric and historic potters; the park contains cultural resources dating from the Paleoindian stage. Park personnel along with Lucy Bambrey and Scott Phillips, who conducted the cultural resources survey of the park, will lead a tour of the resources.

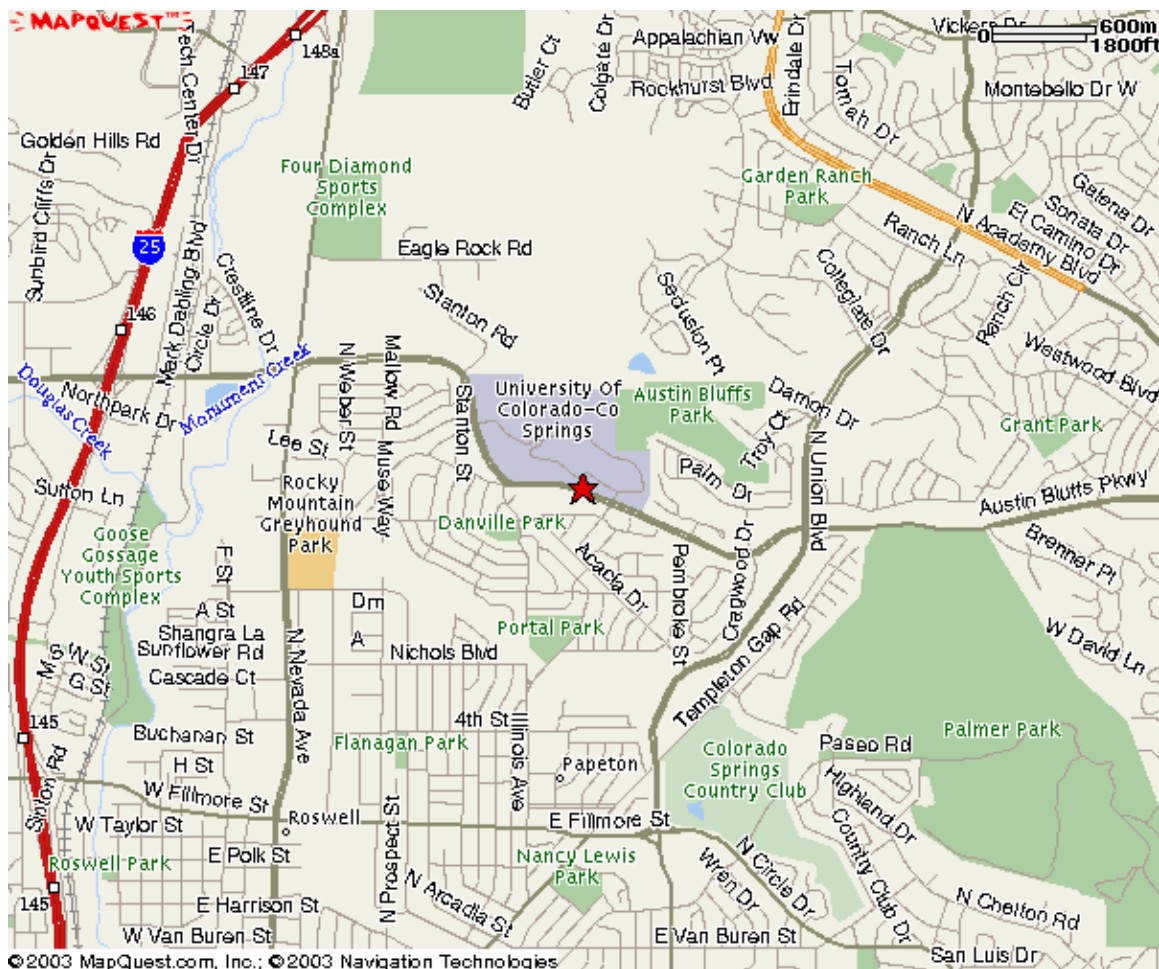

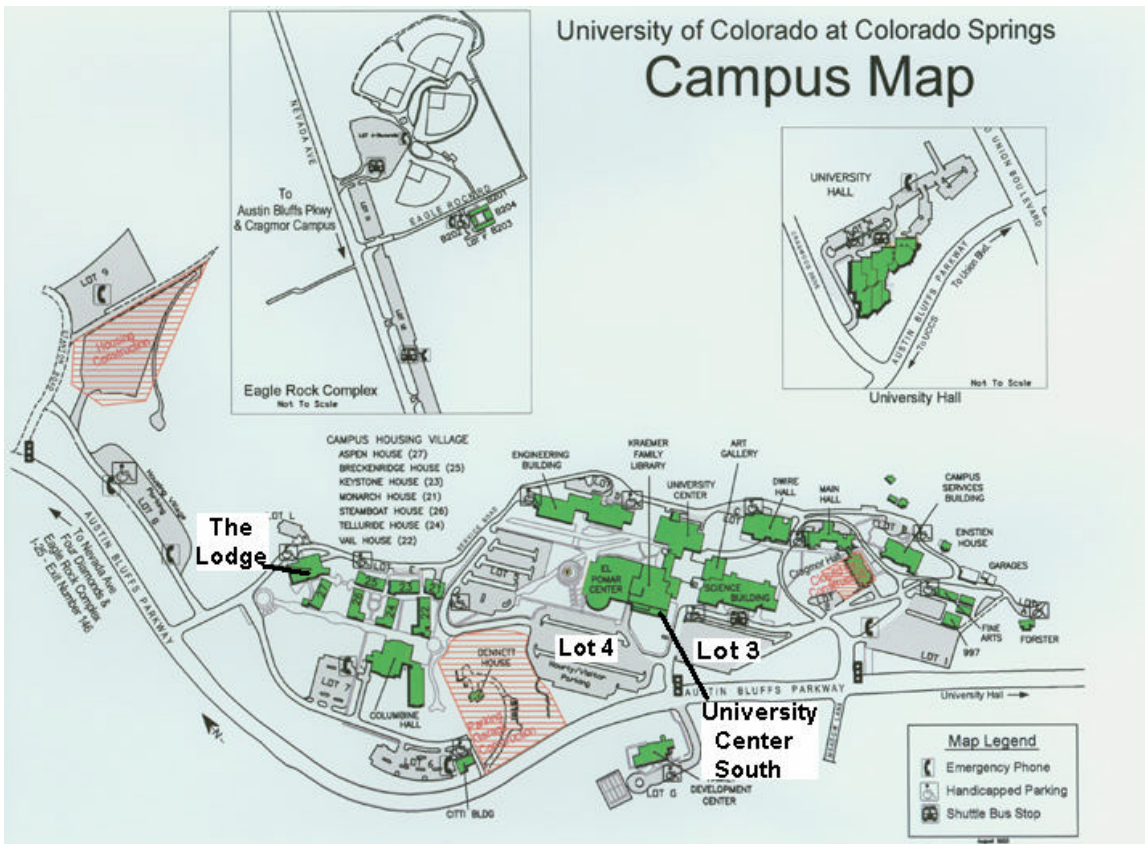

Candidate Profiles

President:

Kevin Gilmore: I am the Director of the Archaeological Research Institute (ARI) at the University of Denver, and a PhD student in the Department of Geography at DU. I grew up in Denver and received a BA in Anthropology from Colorado College in 1981 and an MA in Anthropology from CU-Boulder in 1991. I've been a member of CCPA since my early days in graduate school at CU. My first experience in archaeology was in 1979 as a crewmember during the excavation of the Bayou Gulch site by the Colorado Highway Department, which later became the subject of my master's thesis. I have worked as a professional archaeologist in both crew and supervisory positions in Colorado, Wyoming, Utah, New Mexico, and Alaska for private archaeological contractors, the Colorado Department of Transportation, the U.S. Forest Service, and the University of Colorado. As Director of ARI, I am currently supervising grant-funded research on the archaeology of the eastern plains of Colorado, including preliminary analysis of the collection of perishable artifacts from Franktown Cave funded by the National Science Foundation, and ongoing work on a Multiple Property Documentation Form for Prehistoric Rockshelters in the Palmer Divide funded through the State Historical Fund. My recent fieldwork includes running a field school at the Cherry Creek Canyon rockshelter for the DU Anthropology Department, high altitude survey in Rocky Mountain National Park for a joint NPS-University of Northern Colorado project, and several projects for RMC Consultants including survey of salvage timber sales within the desolation of the Hayman burn area (weird) and site testing under the watchful eye of 19 year-olds with automatic weapons guarding mustard gas at the Pueblo Chemical Depot (weirder). In addition to being one of the authors of *Colorado Prehistory: Prehistoric Context for the Platte River Basin*, I have

presented 17 papers at professional conferences and have authored 11 publications (five currently in press), as well as numerous technical reports. My research interests include Prehistory of the Great Plains, Rocky Mountains and Southwest culture areas; cultural ecology of hunter-gatherer and agricultural societies; paleodemography and prehistoric population dynamics; paleoenvironmental reconstruction; geoarchaeology; and archaeological applications of geographic information systems (GIS).

Ted Hoefler: is currently a Senior Archaeologist at RMC Consultants, Inc. in Lakewood, Colorado. Ted grew up in the San Luis Valley of Colorado and earned B.A. and M.A. degrees in Anthropology from Colorado State University in 1979 and 1987, respectively. His first experience in archaeology was in the Colorado State University field school in Canyon Pintado, Rio Blanco County, Colorado in 1979. Since then Ted has worked on projects in Colorado, Wyoming, Utah, Arizona, Montana, Arkansas, Oregon, Michigan, and Wake Island in the mid-Pacific ocean. Most recently, Ted designed and implemented the research design for the Great Sand Dunes Eolian System Anthropological Project at the Great Sand Dunes National Monument. The research design grew out of Ted's work as the co-author of *Prehistory of Colorado: A Context for the Rio Grande Basin*. Ted is currently working on a large test excavation project at the Pueblo Chemical Depot, Pueblo County, Colorado and on an archaeological evaluation of the Anvil Points Oil Shale refinery and town site near Rifle, Colorado. At RMC, Ted is responsible for designing and implementing project research designs, integrating new field and laboratory methods into projects, authoring reports, supervising staff archaeologists, and marketing and bidding on projects.

For the past two years Ted has served on the CCPA Executive Board, chaired the CCPA public policy committee, and has represented

CCPA on the Colorado Preservation, Inc. public policy committee. In addition to CCPA, Ted is a member of the Society of American Archaeology, Register of Professional Archaeologists, and the Rocky Mountain Association of Environmental Professionals.

I feel that CCPA is an extremely important organization. CCPA provides professional and student archaeologists in Colorado a forum for collegial exchange, opportunities to interact with the public, and a platform to participate and influence public policy decisions affecting archaeology and historic preservation. As president, I would like to continue CCPA's involvement in the curation issue, continue the effort to attract new members and retain current members, increase student involvement, promote professionalism and the open exchange of ideas and research, and help CCPA become an active participant in public policy issues that affect our profession and Colorado archaeology. It is my hope that CCPA will continue to grow as an organization and that I can do my small part to contribute to this growth.

Secretary:

Heather Mrzlack: I am a staff archaeologist with RMC Consultants, Inc. I have worked with RMC since 2001 and enjoy the constant learning experiences obtained by working with everyone there. I graduated from Purdue University with a BA in 1996 and completed the anthropology graduate program at the University of Colorado at Denver this December (2003). The focus of my thesis was analyzing ochre from a 10,000 year-old cave site (49-PET-408) in southeast Alaska. I wanted to determine if ochre could potentially be used as a sourcing material. Results were very promising, but more research needs to be conducted on ochre sources areas.

I enjoy the work that I've been able to do as an archaeologist. I have conducted fieldwork in Peru with Jon Kent, in Alaska with Jim Dixon for two summers, and several places in

Colorado and Nebraska with RMC. I have slept in a tent for three months in a cold, rainy, bear infested area. I have auger tested while I was 7 months pregnant. Finally, I have met some of the best people in the world through archaeology.

I have been a member of the Colorado Council of Professional Archaeologists since 2002. I would be honored to be secretary of CCPA. I believe it is a wonderful organization and I would love the opportunity to meet more Colorado archaeologists and to learn more about the organization and the many challenges it faces.

Treasurer:

Joel J. Tyberg, MA, RPA: Mr. Tyberg holds a B.A. in Anthropology with a concentration in Historic Archaeology from the University of Maryland, College Park (1996) and an M.A. in Anthropology with a concentration in Southwestern Archaeology from the University of Colorado, Boulder (2000). In addition to running his own company, Mr. Tyberg has worked at several CRM firms in the Denver Metropolitan area. He is currently employed with RMC Consultants in Lakewood.

Statement:

I have been hoping for an opportunity to become more involved in the CCPA. If elected Treasurer, I will use the influence of the position and my knowledge of current issues of importance to CCPA to focus on:

- getting to know as many of my fellow Colorado archaeologists as possible,
- ensuring that revenues exceed expenses – utilizing a financially sound approach for funding membership initiatives,
- marketing the Council's services to promote the role of archaeology in both business and academic settings, and
- emphasizing the energy, strengths, and diversity of our membership.

Board Members:

Norma Miller: I am Norma Miller and I live near Park, Douglas County, Colorado. I am a graduate of Metropolitan State College of Denver with a BA in Anthropology but my interest in archaeology goes back many years before that.

My grandfather was an amateur archaeologist in Fowler, Colorado. As a child I would go with him to "hunt arrowheads." His name was R.D. Mutz and he was one of the E. B. Renaul's informants in the early 1930s.

Since graduating, I have worked mainly in Douglas County. One big project over the last 10 years has been documenting the Russellville area of Douglas County. A metal detecting survey was done over 3 field seasons. The results are in the final state of a local district landmark nomination. I am an archaeology advisor to the Douglas County Historic Preservation Board and have done surveys as well as advising the County Planning Department of potential archaeological resources on lands being developed. I have been on the Board of Denver Chapter CAS as librarian and a board member of the Parker Area Historical Society. I also am director/curator of the Douglas County artifact repository. It is a facility with great potential for expansion to a functioning research, curation and storage resource.

My major focus is on educating the county planners and developers on the need for surveys before any dirt is disturbed.

I feel that CCPA is an essential organization to accomplish education of local governing entities, in particular, to the importance of archaeology. I look forward to serving on the Board of Directors and facilitating public education and the curation crisis.

Jason Eckman: Like many of you I became interested in archaeology, geology and the outdoors when I was very young. I attended Western State College in Gunnison, Colorado

and in between fishing skiing I was able to earn a B.A. in Geology with an Anthropology emphasis. While at Western, I worked on the Tenderfoot site for Dr. Mark Stiger for two seasons and did lab work in the off season. After graduation I went to work as a Geologist on a drilling project near beautiful Rawlins, Wyoming. After five months the project was completed and I decided I wanted to give Archaeology a shot. I began working seasonally for Alpine Archaeological Consultants, Inc. in 1995 and became a staff archaeologist in 1998. Since then, my career at Alpine has given me many opportunities to work on some incredible projects and amazing sites. Most recently, I excavated an Archaic house pit near Kemmerer, Wyoming for the Kern River Pipeline Project. I have been a voting member of CCPA for 5 years and am looking forward to getting more involved in the organization.

Kae McDonald: I have been employed as an archaeologist since 1983, and have worked in Colorado since 1989. I received my Ph.D. in archaeology in 1994 from the University of Colorado. I have worked for Metcalf Archaeological Consultants, Inc., and I served as the Director of the Frontier Historical Museum for 1½ years. I am currently working as a private consultant. My professional interests include Great Basin archaeology, exchange theory, ceramics, and local historical topics of the Roaring Fork Valley and Western Slope including CCC Projects, early industrial archaeology, and cemetery studies. I served as the CCPA Newsletter Editor for three years in the mid-1990s and, if elected, will commit to doing my best to represent and support CCPA.

News Briefs

President's Corner

Here are some updates on matters reported on in the last newsletter, and a couple of new items.

Human Burial Legislation

Mark Mitchell and his Liaison Committee did a great job in collating and summarizing input from the membership and provided comments on the draft legislation to the Colorado Commission on Indian Affairs (CCIA) in the fall. In general, the comments were critical of the draft bill's failure to provide for scientific study of burials, and they advised the CCIA that CCPA could not support the bill as

written. However, the comments noted our willingness to work with CCIA to revise the draft and develop a bill that would be mutually acceptable to all interested parties. I have also recently communicated that position to the CCIA. At this time we don't have any information about efforts to redraft the bill or if a bill will be introduced in the 2004 Legislative session.

Ancient Colorado

10,000 copies of *Ancient Colorado* are now available for \$7.95 from the University of Utah Press and at the Colorado Historical Society Gift Shop. The road to get this reprint done was far from smooth, and a number of obstacles had to be overcome. Kudos to Anne McKibben and the Publication Committee for an outstanding effort.

CPI Action Network

Although the Executive Committee decided not to provide the CCPA mailing list to Colorado Preservation, Inc., we do feel that our membership would benefit by individual participation in the network established by CPI. To that end there is information in this newsletter on how individuals can provide mailing/email addresses to CPI and receive alerts through the network. Annual Meeting

TWENTY FIVE YEARS AGO IN COLORADO ARCHEOLOGY. . . .

1979

- The fourth **CRABS** (Cultural Resource Academic – Bureaucratic Symposium) get together occurred February 5 at the Oxford Hotel as called by Primer Crab Bruce Lutz. The main criterion for papers was irrelevance. The **Red Rubber Tomato Award** was presented for the most ill conceived paper, and the **Dildo Ducky Award** went to the most illicit contribution to theory and method. No minutes or notes were kept, so award recipients remain unknown
- CCPA's first annual meeting was held March 1-2 in the Boettcher Auditorium, Colorado Heritage Center, Denver. The organization's first formal slate of officers was elected, and four Standing Committees were created: Nomination, Revocation Procedures, Finances, and Membership.
 - President – Doug Scott (BLM – Montrose)
 - Vice President – Frank Eddy (University of Colorado – Boulder)
 - Secretary – Dave Stuart (Office of the State Archaeologist of Colorado [OSAC])
 - Treasurer – Kris Kranzush (Gordon and Kranzush, Inc)
 - Executive Committee Members: Beth Walton (BLM – Craig), Bruce Rippeteau (State Archaeologist), Dave Breternitz (University of Colorado – Boulder), and Liz Morris (Colorado State University)
- Issues of concern to CCPA members:
 - OSAC's competing for CRM contracts. State Archeologist Bruce Rippeteau indicated that neither he nor OSAC would seek to contract on a competitive basis (see Vol. 2, No. 1, February 1979 of CCPA's Newsletter for additional information).
 - Big Industry requests for CR clearance despite considerable snow cover. A position paper against the practice of conducting field investigations that involved the monitoring of snow removal activities was prepared by CCPA ad hoc committee, presented by Kinzie Gordon, and formally adapted by the CCPA membership. This issue was also a topic of discussion at the fall 1978 Plains Anthropological Conference (see minutes of CCPA annual meeting published in Vol 2, No. 2, September 1979 Newsletter)
 - No collection strategy. CCPA members passed a motion opposing blanket “no collection” approach.
 - Incorporation of CCPA as a not for profit organization. Motion for incorporation of CCPA was passed.
- The newly introduced bill, Archeological Resources Protection Act, was referred to a CCPA ad hoc committee for review to provide recommendations to the membership.

Attention All Student Members

At the 2003 annual meeting the Membership amended the bylaws to allow for the formalization of two new categories, the Student Voting Member and the Student Associate Member. In order to certify each student member's eligibility, the membership committee requests that **all current students re-apply** to one of these two categories.

The procedure is straightforward and involves the submission of a professional resume (or vitae), a signed agreement to adhere to the Code of Ethics, the correct number of professional references (3) for Student Voting or (1) professional reference for the Student Associate category, and both categories require proof of enrollment in either a postgraduate or undergraduate degree program. This proof could consist of a copy of a valid student ID card, a letter from a professor or other appropriate school official, a class enrollment list, etc. For Student Voting Members, upon completion of the postgraduate degree the individual automatically becomes a full Voting Member without the need to re-apply. Both membership category dues have been currently set at the reduced rate of \$10.

a. Qualifications

- i. Minimum of a BA or BS degree in anthropology or related discipline, and
- ii. Minimum of 2 months full-time professional archaeological experience.
- iii. Actively enrolled in an advanced degree program in anthropology or a related discipline.
- iv. Written agreement to adhere to the Code of Ethics.

b. Entry Procedures

- i. Application to be accompanied by a current professional resume, three professional references, and proof of enrollment in a postgraduate degree program.
- ii. Accepted by a 2/3 vote of the Membership Committee after a review of credentials.
- iii. Exceptional cases may be referred to the Council as a whole by the Membership Committee.

c. Rights/Responsibilities

- i. Adherence to the Code of Ethics
- ii. Regular participation in the activities of the Council.
- iii. Full Voting rights in all Council business
- iv. Eligibility to serve as Council or member of

any Council committee.

v. Receipt of all Council publications.

vi. Upon completion of the postgraduate degree, the individual will become a Voting Member

and will be required to pay the full dues for that status with the next annual renewal.

vii. Pays at a reduced rate compared to a regular Voting Member as set by Council.

Section 8. Student Associate Members

a. Qualifications

i. Written agreement to adhere to the Code of Ethics, and

ii. Active participation in a BA degree program, in anthropology or a related discipline.

b. Entry Procedures

i. Application to be accompanied by a current professional resume, one professional reference, and proof of enrollment in an undergraduate degree program and

ii. Acceptance by majority vote of the Membership Committee after a review of credentials,

iii. Exceptional cases may be referred to the Executive Committee by the Membership Committee.

c. Rights/Responsibilities

i. Adherence to the Code of Ethics.

ii. All rights of Associate Members including no voting on Council business, no membership on standing committees, and no serving as a Council officer.

iii. May serve as a member of any ad hoc committee, excepting ethics review committees,

provided that Associate or Student Associate Members do not constitute more than 1/3 of the committee membership.

iv. Receipt of all Council publications.

v. Placement on Membership listing.

vi. Upon completion of the undergraduate degree, the member must reapply as either an Associate or Voting Member during annual renewal.

vii. Pays at a reduced due rate as compared to a regular Associate Member as set by Council.
